3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

4. Details of our assessment

The site was visited as part of the routine checks around Cemaes at the start of the bathing water season.

It was seen during the visit that the manhole covers on the storm overflow tank and screen could not be lifted to inspect underneath. The manholes were sealed with silt that had collected over time. This evidence suggested that the manholes had not been lifted for a long time, which brings into question the maintenance of the screen and the storm tank.

In addition, it was seen that the tidal flap on the emergency discharge was blocked with stones and pebbles that had washed up the emergency outfall. (see attached photo P5080055).

Action:

1. Please provide evidence that the screen and storm tank can be accessed, i.e. evidence that the manholes have been lifted since the inspection.
2. Please provide evidence of your maintenance regime for the site.
3. Please clear the stones and pebbles from the tidal flap chamber of the emergency discharge.
