4. Details of our assessment

DCWW self reported a spill to the environment from the storm outfall at Treuddyn WwTW on 1st May 2026. DCWW submitted a storyboard on 15 May 2026, detailing their investigation findings and actions that were undertaken to rectify the issue.

The blockage impacted the site at approximately 18:35 to 22:55 on the 1st May 2026. Telemetry data shows FPF was at zero for the duration of the spill.

DCWW reported that the spill was due to a partial blockage on the inlet which restricted the site from achieving full FPF. The blockage was removed allowing flows to return to normal and the site to return to operation. Site spilled to storm and discharged from the storm outfall for approximately 3 hours.

No samples were collected during the spill as access to the watercourse was deemed unsafe due to the outfall being located at the base of a steep embankment.

The findings of the investigation were escalated to the standby pollution technician and an alarm review was undertaken.

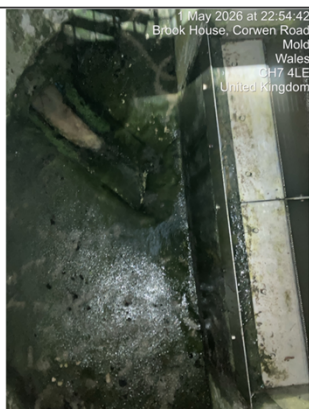
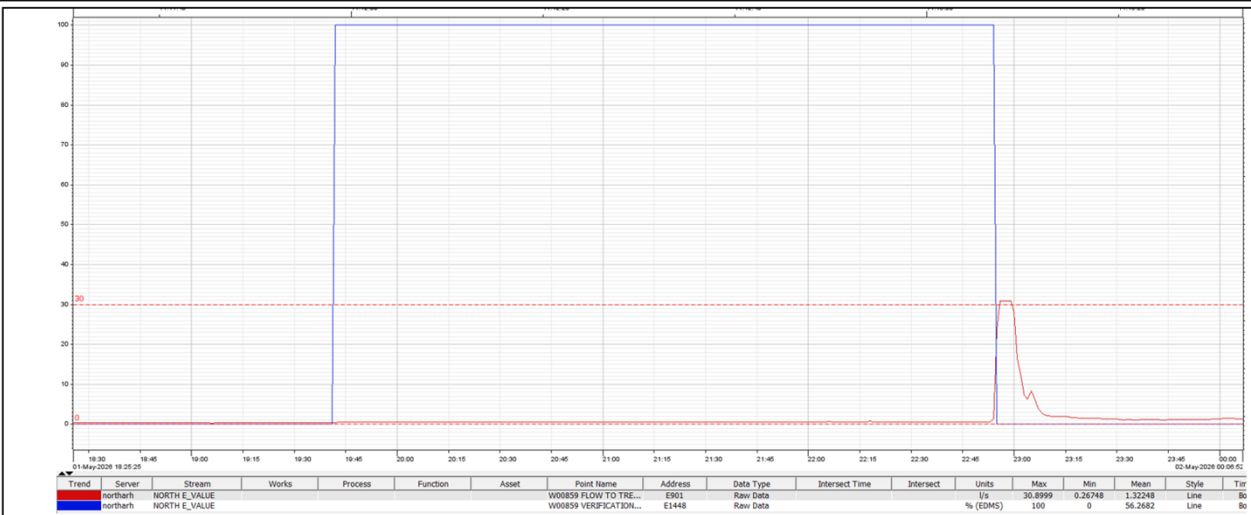


Figure 1 – shows the CSO
