4. Details of our assessment

This compliance report is the result of a site visit that was carried out by NRW on 29/04/2026.

Arrived at site at 10:00am and met with onsite personnel. Went down to the onsite treatment works for inspection which looked to be in good working order. Checked the final effluent chamber of the treatment works which looked good.

This year, the site had a few residents on site permanently which allowed for constant flow through the treatment works during the winter months where the site would have usually been vacant, which usually has an impact of the effectiveness of the system.

This site is in compliance with its permit and no further action is required.
