4. Details of our assessment

A routine sample taken on 22/04/2026 returned a suspended solids result of 59 mg/l against a permit limit of 30 mg/l.

Further to the CAR (Ref: NRW0051830) received on 13/05/26 relating to an elevation of Suspended Solids from a sample collected by NRW on 22/04/2026 at Castlemartin (Merrion Camp) STW01, AWS conducted investigations and determined the cause of the elevation to be a sudden un-notified increase of population in the catchment, leading to increased flows that enabled settled solids within the process to be carried through the asset.

A routine UKAS accredited sample had been collected the day prior on 21/04 with a compliant Suspended Solids (SS) of 6mg/l. Routine field data collected on 27/04 returned a Turbidity of 5NTU. Evidencing that the increased SS was a short-term elevation. In addition, a further routine UKAS accredited sample was collected on 07/05/26 returning a result of 4mg/l, further evidencing that the asset was within compliance and the elevation was not persistent.

Population changes will be requested from site to inform AWS ahead of the change to enable alterations to management of the asset if required.
