4. Details of our assessment

Chris Gurney and I attended site for an unannounced inspection on the 1 May 2026. Weather conditions were dry and sunny, following a prolonged dry period. Watercourse levels were normal to low.

The manner and extent of impoundment was inspected. The structure was measured and fit with the design stated within the impoundment licence. The physical structure was in good condition with no obstructions or leaks.

This license was inspected along side the abstraction licence: WA/056/0041/0007.
