4. Details of our assessment

On 08 April 2026, as part of NRW's regulatory monitoring programme, a sample was collected from the waste treatment plant at the THE NATIONAL TRUST permit ID WQD003926 .

The sample was analysed at the NRW laboratory and was found to be non-compliant for Ammonia. The permitted limit for Ammonia at this site is 15mg/l, while the analysed sample returned a concentration of 48.4mg/l.

Required Action

The operator is required to investigate the cause of the treatment system's failure to achieve the permitted limits for Ammonia.

Ensure treatment plant is achieving permitted allowance.
