Schedule Notification Part A/B – Leachate Head Breach

Summary:

Leachate well LMP3/2 remains in breach of permit limits and a further schedule notification for this breach has been received by NRW. The permit condition(s) relating to this breach are listed below:

2.9 Leachate levels

Permit Condition:

2.9.1 The limits for the level of leachate listed in schedule 4 table S4.1 shall not be exceeded.

Schedule 4 – Emissions and monitoring

Table S4.1 Leachate level limits and monitoring requirements require leachate levels in monitoring wells below 2m.

The Schedule report of permit breach for leachate level in-well, dated 27-05-2026 in leachate well LMP3/2 at 5m, shows this is over the 2m permit limit. ***The score for this breach is a CCS3 minor breach.***

Site Response:

Site management and environment department have responded with the following statement:

Elevated level within LMP3/2 largely due to formation of a polyacrylate gel inside the chamber which impedes the operation of any pneumatic pump type. FCC opted in favour of a high-power electric pump installation, with the hope that the pump would be able to deal with the thick gel much better than previous pumps. The level in LMP3/2, while still non-compliant, has significantly dropped over the month. Pumps and levels here continue to be closely monitored.

ACTION-. All works detailed above to be completed and the leachate level in this well to be brought into compliance by the 30th June 2026
