4. Details of our assessment

Introduction

The operator has submitted a revised working plan (dated 08/08/2025) which confirms that the landfarm plots are functionally closed and have not been used since the initial notice from the Environment Agency to cease taking waste in 2003.

Ahead of the operator submitting an application to Natural Resources Wales to amend the permit to reflect closed status, the site was visited and the plots used for landfarming were visited to verify that the closure notices have been adhered to.

Landfarm Plots

During the visit, all of the formerly operational landfarm plots were visited, with the exception of Plot 9. Plot 8 was never used for deposition of waste.

The photos above show the current state of some of the landfarm plots, in summary:

- Plot 2 - unmanaged, unmown
- Plot 3 - unmanaged, unmown
- Plot 4 - some of the plot has been maintained as a clear area for materials laydown, the rest is unmanaged and unmown
- Plot 5 & Plot 6 - mown areas on the site boundary

- Plot 7 - mown at fenceline

During walkovers of all the visited plots, there were no signs of bare soil or hydrocarbon staining and no sign of recent deposition of oily wastes or ploughing. Vegetation, even where mown, shows signs of being well established, with scrub or small trees present in places on most plots.

Summary

The revised Landfarm Working Plan submitted by the operator confirms that the landfarming operations have not taken place since 2004.

No sign of recent landfarming operations were visible on any of the plots visited.

Notwithstanding any other specific requirements, the updated Working Plan and this Compliance Assessment Report should accompany any variation of the waste permit to put the site into closure.
