### 4. Details of our assessment

Routine inspection of permit following query on sample point location from NRW sampling staff.

The site has installed a new package treatment plant in approximately the last 5 years but the discharge goes to the same original point on the permit at NGR SN54832553. Photos taken of locations and discharge pipe for sampling staff. It was confirmed that there is no separate sample point.

At the time of the visit there was very low flow in the system with only a trickle discharging from the pipe. NRW request that the discharge point be double checked for integrity using a dye or by flushing water down from the manhole after the treatment plant. Please ensure the discharge point is accessible to our sampler who will contact the site on attendance by signing into the reception.
