4. Details of our assessment

This CAR form (Compliance Assessment Report) has been completed following a site familiarisation visit by NRW officers in association with the Environmental Manager and the Sales Manager for Radnor Hills

Overall the site was very clean and tidy, and at a brief, high level inspection, no issues were noted during the site inspection.

IR3A(1) Emissions to Water

NRW officers were shown around the AD plant, and discussed upgrades to the settling tanks. A second balancing tank is being constructed, together with a new monitoring point which will help the operators to maintain pH levels.

Officers inspected the discharge point W1 within the site boundary as well as the swale and discharge point to the River Teme.

A secondary balancing tank is currently being constructed, together with a new water quality monitoring point with the aim of creating a more stable environment within the AD plant.

IR3A(2) Emissions to Air

The operator has previously confirmed via email that Boiler 3 was decommissioned. This site visit highlighted that Boiler 3 has now been removed from site, which has effectively made emission monitoring point A3 obsolete.

Possible future plans were discussed. The operator was reminded that any potential amendments or upgrades to the emissions to air will require a permit variation being in place before the commencement of any on-site works.

IR4B Reporting

The operator is reminded that the parameters for emissions to water - W1 as required by condition 3.5.1 should be collected on a monthly basis, but may be sent through to NRW on a quarterly basis. For clarity the returns for Q1 - January to March should be submitted to NRW by the 28th April; returns for Q2 - April to June should be submitted by the 28th July, Q3 by 28th October, and Q4 by 28th January.

Pre-operational measures for Future Development - PO1

PO1 advises the operator to notify NRW two weeks in advance of the change in ferric chloride dosing from using 25 litre containers to 1m3 Intermediate Bulk Containers (IBCs). Notification was received via email on 28th April of the changeover in advance of the transition expected to be completed by mid-June. Storage and containment of the larger containers was inspected during the site inspection, and found to be acceptable. NRW considers that PO1 has been discharged.
