4. Details of our assessment

This compliance report is the result of a site visit carried out by NRW on 29/05/2026.

Arrived on site with DCWW who lifted the manhole covers for inspection. This asset spills into the combined sewer on Maple road which then discharges at the outfall near Owain

Close (Cornerswell storm overflow) in the event of a spill.

The maintenance frequency of this asset is once every 6 months and was carried out in February 2026. The overflow into the sewer at the time of inspection was clear with no signs of pollution.



NRW have decided that this asset is compliant with its environmental permit and no further action is required.
