4. Details of our assessment

This compliance report is the result of site visit carried out by NRW on 29/05/2026.

Arrived on site with DCWW at 10:40am. This asset last spilled on 14/11/2025 according to the DCWW storm overflow map.

Started at the storm overflow near Owain Close which showed some signs of misconnections but no signs of sewage fungus or debris present. This outfall also apparently takes overflow from nearby CSO's in the area (Maple road CSO, Cornerswell CSO and Countess place CSO).



Went to Cornerswell lane where the asset is situated and DCWW lifted the manhole covers for inspection. The screens on this occasion were clear. DCWW said that the maintenance frequency for the screens at this asset are once every 4 months, with the last maintenance carried out in April 2026.



NRW have decided that this site is within compliance of its environmental permit and no

further action is required.
