4. Details of our assessment

This Compliance Assessment Report follows an unannounced inspection of the site on 14 April 2026. Officers met with the Operations Director and Environmental Manager.

Concurrent monitoring of heavy metals had been undertaken that morning at emission points A26 (K7 Biomass Boiler) and A29 (MDF2 cyclone). At emission point A29 post monitoring calibration was being undertaken. At emission point A26 sulphur dioxide and total particulate matter monitoring was being undertaken. Officers spoke with the monitoring personnel based at both locations; no issues were raised.

The Operator stated that they had installed the SNCR but this was not yet operational.

The vibration identified at the A26 emission point previously had reduced.

There was a significant spill of dry fly ash under the EWK scrubber by emission point A26. Following further discussions with the Production Director it was identified that there had been a blockage on the screw that was cleared on 13/04/2026 but the spilt dust had not been cleaned up. Officers reminded the Operator that there was the potential for wind blown fugitive dust emissions because of the debris. **This has been scored a category 3 breach of condition 1.1.1 (Compliance criteria (IR1A) General Management).** The Production Director stated that the debris would be cleared following the visit.

Action 1: Ensure that all future maintenance activities include tidying up after the event. This will be monitored at future inspections.

The K7 biomass boiler fuel was observed to be refiner fibre and MDF board; there was no evidence of contamination. The K7 grate mister was operational. Officers spoke with operatives in the boiler control room. No issues were identified in relation to the operation of the K7 biomass boiler. Operating temperatures appeared to be stable.

The bunded area adjacent to Dryer 4 was flooded. The underground tank was full and

needed emptying. There were numerous full IBCs being stored in this area. There is the potential that should there be a spillage from these IBCs that it could overtop the bunded area and there is the risk of pollution due to contaminated water. **This has been scored a category 3 breach of condition 3.2.3 (Compliance criteria (IR3B) Emissions of substances not controlled by emission limits).**

Action 2: The Operator should empty the liquid from the tank and bund area by 15/06/2026.

Action 3: The Operator should review the containment in this area and ensure rainwater is suitably managed. Relevant procedures should be reviewed and updated as necessary. These may be reviewed at a future inspection.

Stockpiles within the logyard had reduced. Shredding was in operation for chipboard pre production. It was confirmed that the shredder is now washed between the different shredding operations. The log partition wall adjacent to the bark had partially fallen. The Operator should ensure that the dividing walls are stable.
