4. Details of our assessment

THIS CAR FORM IS BEING ISSUED TO ACCOUNT FOR THE EMISSIONS AND MONITORING FAILURE OF AMMONIACAL NITROGEN AS N and BOD (Biochemical Oxygen Demand).

On 19th of May 2026, as part of NRW's regulatory monitoring programme, a sample was collected from the package treatment plant sample point at the LLECHWEDD SLATE CAVERNS CENTRE Ltd (Permit: LB3690HV).

The sample was analysed at the NRW laboratory and was found to be non-compliant for Ammoniacal Nitrogen. The permitted limit for Ammoniacal Nitrogen at this site is 10 mg/l, while the analysed sample returned a concentration of 147 mg/l. It was also confirmed that BOD (biochemical oxygen demand) also failed with the site permitted limit being 20 mg/l but the sample returning a value of 43.5 mg/l. Suspended solids also failed with a sample result of 60 mg/l and the site only permitted for 30 mg/l.

Required Action

Please investigate the cause of the treatment system's failure to achieve the permitted limits for Ammoniacal Nitrogen, BOD and suspended solids.

Please ensure treatment plant is achieving permitted limits.
