Permit Breaches

W2G - Improvement Programme - Category 3; Permit Rule 2.4.1

The company has been given this Category 3 breach of Rule 2.4.1 as the report required by Improvement Condition 1 has not been submitted to Natural Resources Wales by the deadline of 11 June 2026.

Lloyd Powell (Technically Competent Manager) was reminded about this requirement during the compliance visit on 8 May 2026 and a reminder was included on compliance report CAR_NRW0051739, dated 11 May 2026, issued following that compliance visit.
