4. Details of our assessment

As part of the regulatory monitoring programme, Natural Resources Wales took a sample of the secondary treated effluent from the outlet on the 2nd June 2026.

The results from this sample showed there was an exceedance of the ammonia limit. Table 3.1 of schedule 3 of the permit states an ammonia limit of 20mg/l, and the result of the sample taken was 37mg/l. This has been scored as a CCS3 breach of permit.
