4. Details of our assessment

This was a routine review of data carried out by Malcolm Dines (Waste Regulation Officer) following the deadline for submitting the infrastructure report required by Improvement Condition 1 of this permit.

Permit Breaches

W2G - Improvement Programme - Category 4; Permit Rule 2.4.1

The company has been given the above breach of Rule 2.4.1 as the infrastructure report required by Improvement Condition 1 was not submitted to Natural Resources Wales by the deadline of 11 June 2026. The ruleset for this site, Standard Rules Permit 2018/11, was updated in December 2025 and included this improvement condition. The company was advised of the changes to the permit by a letter 9 December 2025.

It is the responsibility of the operator to ensure that they are operating to the latest version of the ruleset and while the company is not accepting waste as a feedstock at the site, the company must ensure that it is complying with any requirements that still apply to non-operational sites. However, it is because the site is not currently operating as a waste facility that this non-compliance has been scored as a Category 4 breach as there is no environmental risk from the permitted activities by the failure to submit this report.

Action: comply with the requirements of Improvement Condition 1 **by 30 August 2026**

Important information

Legal status of this report

Your permit is issued to you under the Environmental Permitting Regulations. You have a responsibility to comply with the conditions of your permit and prevent pollution/harm of the environment. If you are not satisfied with the outcome of the stage 1 review, you may request a **Stage 2 appeal**. This request must be submitted **within 21 working days** of receiving the response from the stage 1 review.
