Sample Exceedance Report

This CAR form is a review of regulatory monitoring results carried out by NRW (Natural Resources Wales) on 10/02/26.

Breaches of Permit Condition

At 14:34 on 10/02/2026, NRW Data Collection Officers took a water quality sample from the outfall 1 discharge location (NGR ST 07890 91165) named in permit number AF4029101 for Craig yr Hesg Quarry. This sample was part of NRW's routine monitoring program.

The water quality sample was tested and showed 556mg/L of suspended solids. The maximum limit stated in your permit is 200mg/L, when dried at 105°C. The sample contained twice your permitted limit of suspended solids and is classified as a Compliance Classification Scheme (CCS) category 3 non-compliance. This result is a non-compliance of the following permit condition:

3.1.1 The limits given in schedule 3 table S3.1 shall not be exceeded.

Actions Required

3.1.1 Emissions to water:
