4. Details of our assessment

Introduction

This Compliance Assessment Report was completed following a site visit by Natural Resources Wales on 19 February 2026. The aim of the visit was to discuss recent compliance notifications, continuous monitoring arrangements for the Submerged Combustion Vaporisers (SCVs), and to inspect the area around the South Pit, a water discharge monitoring point at the site.

Compliance scoring for the issues discussed below is addressed in NRW CAR_0050635, issued to the operator on 10 February 2026.

South Pit

A site walkover with the HSE Manager, HSE Lead and Insite Environmental Consultant showed the South Pit enclosure. This has reduced the frequency of pH exceedances at the monitoring point, however there are still breaches of the upper pH limit set in the permit, most recently in March 2026 (after the date of this visit).

A previous proposal to remedy this, to remove the retaining wall that forms the weir and increase the flushing of South Pit, appears to not be feasible.

The operator is considering a permit variation application to remove or replace this monitoring point as it is not considered representative of final discharge quality.

Emissions to air - Submerged Combustion Vaporisers (SCV)

The permit requires the operator to carry out continuous emissions monitoring for oxides of nitrogen on SCV1, and quarterly spot samples for oxides of nitrogen and carbon monoxide on all six SCVs.

Accompanied by the Control & Instrumentation Lead, the Continuous Emissions Monitoring System (CEMS) on SCV1 was inspected. The backup CEMS on SCV2 was not visited.

At site, the Control & Instrumentation Department are responsible for management and maintenance of the CEMS at site. A third-party contractor, Element, carries out the quarterly spot sampling on all of the SCVs.

The operator is not required by the permit to comply with *BS14181 Stationary Source Emissions: Quality assurance of automated measuring systems*, however the principles of QAL 2 and QAL 3 as outlined in this guidance [Monitoring stack emissions: Quality assurance of continuous monitoring](#) should be considered as best practice and incorporated into CEMS procedures where applicable. Further to this, the principles of *BS17255 Stationary Source Emissions: Data acquisition and handling systems* should also be considered as best practice for management of data gathered by CEMS.
