4. Details of our assessment

Peter Jones and Alastair Krzyzosiak attended the site on Tuesday 15 June 2026 and met with the owner Elliot Whittall-Williams, site manager Rob and Edward Bennet AWSM Consultancy Ltd.

Stock is supplied to the site by PD Hook Hatcheries Ltd and birds are produced for Maelor Foods Ltd.

A visual inspection of the yards surrounding the sheds was made. The concrete surfaces and drainage were checked. There were no issues identified with the structure or drainage with good clean and dirty water separation.

Documents required under the permit conditions, were checked and these were all in order and available for inspection.

The site was clean and tidy and there were no reports of noise or odour complaints.

Poultry manures are exported from site to the AD Plant Lydney, Plusterwine Biogas Ltd, all transfer documents are in order. MDC Transport Services (Waste Carrier number CBDU499877) transport the litter.

A small portion of the poultry litter is used on Upper Triley farm, and details are recorded on the farm nitrogen management plan. Poultry litter is not stored on the farm, therefore there is no requirement for a manure/slurry store as per the COAPR 21.

Fallen stock is removed from site by Celtic Baits Ltd, Animal by products licence CHP/60/085/800/ABP/FIN. All paper work is in order. The Fallen stock store was locked and secure.

The inspection did not identify any breaches of permit conditions and so there are no recommendations for any improvements required.

To remind the operator, following each assessment Natural Resources Wales will produce a Compliance Assessment Report (CAR) detailing our comments from the audit. If we substantiate reasonably foreseeable risks or actual impact to the environment, we can breach the business against your permit conditions.
