4. Details of our assessment

This was an announced site visit made by Alex Underhill, accompanied by Daniel Grant and Linda Warrick, all of Natural Resources Wales (NRW). The purpose of the inspection was to assess compliance against the tier 3 bespoke Environmental Permit EPR-AP3498FR.

It was noted that there had been periods of heavy rain recently.

Previous inspection:

No permit breaches were observed during the last inspection dated 28/11/2025. Please see Compliance Assessment Report CAR_NRW0050142 for further detail.

Permit Breaches:

No permit breaches were observed during this inspection.

General observations:

The site was generally very clean and well organised, with good segregation of waste types and good waste storage practices were observed.

General Management (W1A):

The site is required to be operated in accordance with a written management system that identifies and minimises risks of pollution.

The Site (W2D):

All specified waste sections were kept separate. The site was well maintained and clean, with recent improvements done to the drainage and impermeable surfaces. The interceptors are newly installed but have previously been routinely emptied. There are sensors on interceptor tanks and oil waste tanks to monitor levels, tanks are cleaned when the levels are sufficient.

Records (W4A):

An up to date EMS and Site Permit were readily accessible on site. All maintenance checks including daily checks had been completed and records were well kept and available.

ADVICE ACTION - With the revised drainage plan for the new interceptors, please ensure the latest copy of the drainage plan is included with the EMS for ease of access.

Reporting (W4B):

Up to date EMS and Site Permit were readily accessible on site. Latest Waste Return Notes up to date, evidence showing up to Q2 2026 has been submitted, despite not showing on the NRW system.

Technical competence:

The TCM for the site holds the appropriate WAMITAB certification. The latest certificate was displayed on site, expiry date on Continual Competency is 22/10/2026.
