The site is located on the west bank of the River Usk, adjacent to Alexandra Docks at the Port of Newport in south Wales, north of the Severn Estuary. ABP propose to remove two structures and supporting piles installed in the intertidal region of the River Usk, adjacent to Alexandra Docks, Newport: - Berthing Jetty Structure No. 3 – 30 m x 19 m wide. The adjacent timber structure is 63 m in length x 15 m wide; and - Structure B - 30 m x 30 m. Works are expected to be completed from an area landward of the structures proposed for removal. However, the final works methodology has not yet been confirmed, and there remains potential that works may be undertaken from a barge operating from the seaward side.
