## 4. Details of our assessment

On 8 June 2026, Dŵr Cymru Welsh Water submitted a self-report to Natural Resources Wales reference 317986865. The report identified that the final effluent from Tal-y-Bont (Dolgarrog) Wastewater Treatment Works (Permit: CG0075501) SS and BOD were recorded at approximately twice the permitted limit.

It is noted that the samples in question were not analysed by a UKAS-accredited laboratory. As a result, these data cannot be relied upon as formal regulatory evidence. However, NRW has determined that further investigation is required.

NRW requests that the following action is undertaken to ensure compliance and understanding of the incident:

### Actions

- Prepare and submit a investigation report that:
  - Identifies the root cause(s) of the elevated final effluent.
  - Details any contributing operational, environmental, or process factors.
  - Outlines corrective actions already taken.
  - Specifies preventative measures to mitigate the risk of recurrence.
  
- Due date for report submission: 31 August 2026

## Important information
