Royal Mint CHP (EPR/CB3595HE)

Emissions Monitoring (Condition 3.5.1)

- Table S3.1 specifies periodic monitoring every 3 years for emissions to air.

Compliance assessment:

- The operator completed first emissions monitoring on 14/07/2023 Within the required timeframe. All emission results were within permit limits
- Monitoring is required every 3 years thereafter, therefore, the next monitoring was due by:14/07/2026
- The operator completed subsequent monitoring on 15/05/2026. Within the required timeframe.
