4. Details of our assessment

Thank you for submitting your climate change risk assessment for Harp International, Gellihirion Hazardous Waste Reclamation and Storage Facility, at CF37 5SX, operated under Environmental permit EPR/NP3099FS.

We have carried out a light-touch review of your risk assessment and are satisfied that it generally meets our current climate change risk assessment requirements under Regulation 61 and permit condition 1.1.1(a), however there were several areas where improvements could be made;

1. 2° deg C rise by 2050, and 4 deg rise by 2100 scenarios. The CCRA should be clear that the risk assessment is based upon these scenarios. These are mentioned within the text but it is unclear that the CCRA is based upon these.
2. Key Performance Indicators (KPI's) are not included.
3. Clearly defined risk assessment methodology is not detailed. This makes it impossible to see with transparency how the risks have been classified as low/medium/high.
4. The high rain scenario uses Chemicals sector guidance but does not tailor it to 2050 or 2100 scenarios. Instead, an action is carried forward to an Action plan within the CCRA at p11 (item 3). Site has subsequently shown this is an ongoing item, but the sign off and transparency for this needs to be clear.
5. The effects of high temperatures on staff within the workplace are not considered in the assessment. It is noted there are some measures in place for outdoors personnel.
6. The CCRA does not include a reference to up to date climate projections (UKCP18).
7. The CCRA would benefit from showing a periodic review period. It is understood that the document is under scheduled review, but could be improved by this being annotated on the CCRA itself.
8. There is limited detail on mitigation actions (because risks are assessed as low).
9. Prioritisation of exposed elements should be more structured as they are implied rather than structured.

Action; Consider the 9 points raised for amendment/inclusion/adaptation of the CCRA.

The CCRA is a live document and should be reviewed periodically as part of your Environmental Management System (EMS) or after any significant climate-related events or near misses. We will contact you shortly with further requirements to adapt the CCRA to include a Climate Change Action Plan (CCAP).
