4. Details of our assessment

On 19 May 2026, an announced site inspection was undertaken at TS Reasons Limited, Alyn Works, Denbigh, Mold, Flintshire, CH7 1BT by NRW officers Phil Harper, Lead Specialist, Industry & Waste Regulation, and Hannah Ibbotson, Senior Industry & Waste Regulation Officer.

At the time of the inspection, the site was operational.

Site Improvements

Repairs to the hardstanding near the tank farm have been completed, improving the level of protection to groundwater. Redundant tanks at the rear of the facility have been removed. Planned decommissioning procedures for the removal of the tanks were provided during the inspection and reviewed by NRW. No permit non-compliances were identified.

The operator advised that plans to cover the wash-down catchment pits near the tank farm are in progress.

Reactor A291

Previous correspondence with the operator has discussed the installation of a new phenolic reactor and the mothballing of Reactor A291. Correspondence indicates that the control unit and associated pipework will be removed and capped following decontamination.

During the inspection, a written plan for this work was provided to NRW officers. Review of the plan has not identified any permit non-compliances.

Reactor A291 will be left in situ. The operator is reminded that a permit variation must be approved prior to bringing Reactor A291 back into operation following the installation of the new reactor and its subsequent mothballing.
