4. Details of our assessment

Site Inspection Summary

A site inspection was carried out in the presence of two representatives from the permit holder, Dŵr Cymru Cyf.

This site is a dry well system. Access to the ground floor was safe, however, the lower floors were out of bounds due to it being a confined space. Gas test before entry requirements was clearly noted on top of the stairs that entered the majority of the works. It was explained by Dŵr Cymru Cyf. representatives that staff attended the site on a quarterly basis. The site included lifting gear.

No non-conformances were identified in relation to the permit conditions.

Health and Safety Observations

The following health and safety observations were noted during the visit:

- The ground floor guardrail is inadequate to prevent falls.
- Confined space and associated gas testing control areas may need to be extended to include the ground floor.
- Appropriate ventilation pipework for the building is unknown due to inaccessibility to all areas of the site during the inspection.
- It was unknown if all appropriate signage on site were adequate due to inaccessibility to all areas of the site during the inspection.

Recommendations

The following actions are recommended:

- Assess what additional protection required on the ground level guardrail as well as other guardrails on below ground levels that were inaccessible during the inspection, eg, kick bar and/or intermediate rails to reduce serious risk to personnel, particularly those operating lifting equipment, falling to the levels below.
- Assess whether the confined space area should be extended to include the ground floor.
- Assess whether additional ventilation is required within the building.
- Review and update all relevant signage, including confined space designation and noise warnings, to ensure clarity and compliance with health and safety standards.
