4. Details of our assessment

Site Inspection Summary

A site inspection was carried out in the presence of two representatives from the permit holder, Dŵr

Cymru Cyf.

No non-conformances were identified in relation to the permit conditions.

Health and Safety Observations

The following health and safety observations were noted during the visit:

- The opening to the old connection pump has not been physically blanked off and is currently covered only by a moveable sign.
- There is no signage on the main (and only) access door to the single-room structure to indicate that it is a confined space or to highlight the requirement for gas testing prior to entry.
- The building does not have dedicated ventilation pipework, with ventilation limited to vents located on the access door. One of these door vents is damaged.
- Noise warning signage displayed on the door has faded and is no longer clearly legible.

Recommendations

The Dŵr Cymru Cyf. representative suggested that a flange blanking plate be installed to properly seal the opening to the old connection pump. In addition, the following actions are recommended:

- Repair the damaged door vent.
- Assess whether additional ventilation is required within the building.
- Review and update all relevant signage, including confined space designation and noise warnings, to ensure clarity and compliance with health and safety standards.
