Warning

On 11th June 2026 a routine sample was taken. The analysis showed the discharge to be non-compliant with permit conditions.

Condition 1.6 Composition

Discharge shall not contain more than:

40mg/l biological oxygen demand - sample result: **54 mg/l**

60mg/l suspended solids - sample result **100mg/l**

Please be aware that this report contains a warning and you are required to carry out works to prevent a recurrence. Please ensure this is carried out before 21st July 2026.
