## 4. Details of our assessment

**Poeton Cardiff Ltd**

**EPR/BP1772IZ**

This compliance assessment report (CAR) details the light touch review of the operators Climate Change Risk Assessment (CCRA).

The climate change risk assessment for the Poeton Cardiff site is generally well developed and clearly site-specific, with strong reference to its location near the Rivers Ely and Taff and the Cardiff Bay tidal system. It appropriately identifies the main climate hazards affecting the site, including tidal and surface water flooding, extreme heat, storm damage, and drought. Flooding is correctly highlighted as the most significant risk in the near term. The assessment also makes good use of recognised data sources such as Natural Resources Wales maps and UKCP18 climate projections, which supports its relevance and credibility.

The assessment demonstrates a clear understanding of what is at risk on site, identifying key assets such as electrical systems, process infrastructure, hazardous materials, drainage, and access routes. These are sensibly prioritised using a likelihood and impact approach with RAG ratings, helping to focus attention on the most significant risks. In addition, the proposed mitigation and adaptation measures are practical, proportionate, and structured across short, medium, and long-term timescales, which aligns well with expectations for a light-touch risk assessment and shows a good level of forward planning.

However, there are some gaps that limit the completeness of the assessment against the expectations. While actions are phased over time, the risks themselves are not clearly broken down into short, medium, and long-term horizons. Climate projections are referenced but not used in a quantified way to demonstrate how risks may change over time. The document also lacks key performance indicators, meaning there is no clear way to measure progress or effectiveness of the proposed actions. Additionally, although there is a commitment to update the assessment in future, there is no defined review cycle or continuous improvement process.

Overall, the assessment is fit for purpose and meets most of the expectations of a light-touch review, particularly in terms of relevance, site specificity, and practical risk management actions. With relatively minor improvements, such as introducing KPIs, strengthening the review framework, clarifying time horizons, and completing administrative details, it would make the assessment more robust. However, at this stage the CCRA will be accepted.
