4. Details of our assessment

Site Report

On Monday 22nd June 2026 I carried out an inspection at Llangattock Green Valleys Micro Hydro (2) Co-operative Limited, Inland water (stream) known as the Nant yr Hafod at Cwm yr Hafod near Brynmawr, Ebbw Vale, Blaenau Gwent regarding a licence to abstract water (Permit Number WA/056/0033/005). LGV director SS was also in attendance.

The source of supply was the Nant yr Hafod at Cwm yr Hafod with the means of abstraction being intake works and a gravity feed pipe, controlled by a spear valve. The purpose of the abstraction was power production throughout the entire year.

The weather conditions were dry and warm. My inspection commenced at 9.05.

Observations

I can confirm the point of abstraction at National Grid Reference SO 20815 13154 is accurate as stipulated by the permit. Please see Fig 1 below.
