3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

Natural Resources Wales (NRW) officers met with the hotel manager of Tre Ysgawen Hall on 8 June 2026 to undertake a pre-arranged inspection of the environmental permit, as part of the Water Quality Inspection Programme.

Due to circumstances on the day, it was not possible to complete the full inspection as originally intended. It has therefore been agreed between NRW and the operator that a rescheduled inspection will take place in August 2026. A confirmed date will be arranged in due course.

Action Required:

The operator is requested to ensure full familiarisation with the permit and its requirements in advance of the rescheduled inspection.

Non-Compliance

Permit Condition 1.1.3 states:

“Any person having duties that are or may be affected by the matters set out in this permit shall have convenient access to a copy of it kept at or near the place where those duties are carried out.”

The operator requested a copy of the permit from NRW. This indicates that a copy of the permit was not readily available on site, and therefore constitutes a breach of Condition 1.1.3.

Action Required:

The operator must ensure that a current copy of the permit is retained on site and is easily accessible to all relevant personnel.

Deadline: 3 July 2026
