4. Details of our assessment

Natural Resources Wales Senior Industry and Waste Regulation Officers Rick Prichard and Hannah Ibbotson visited Toyota on the 10th June 2026. This was a pre-arranged familiarisation visit, site inspection and follow up to their emissions to air breach in Sept 2025 covered by CAR_NRW0050017. They were accompanied by the Principal Engineer and various other members of staff with responsibilities within the site.

General Management

Officers were taken through the site, including the high pressure casting area, assembly line, foundry and sand moulding area. At this point, officers were shown and discussed the improvements made to the ST12 emission point abatement system and an overview of how they manage the changes for improvement.

Permitted activity

NRW officers were given a tour of the low pressure casting facility. The area was clean, tidy and well organised. The emission points for the activities were clearly designated with information available for all personnel. All emission points were well maintained. Officers were shown their Preventative Maintenance System which indicated they had amended their inspection schedule which now includes one check on the knock out filter every shift (2 shifts per day), and their process for informing shift and engineering managers if problems occur. Toyota also now change the abatement filter every 12 months regardless of its condition.

The site

NRW officers were given a full tour of the site, which was clean and tidy.
