Natural Resources Wales Officer Shaun Rees attended Fir View Tan y Fridd Holiday Home Park on the 9 June 2026 at 13:00 to carry out an inspection in relation to this permit number.

During the inspection, it was evident that no sample chamber had been constructed in accordance with the permit.

Non-Compliances (recorded in summary) Actions to be addressed –

(WQ-C4) Monitoring - Permit Condition 3.3.1 - C3.

No sample chamber had been constructed as stated within the permit.

Permanent means of access shall be provided to enable sampling/monitoring to be carried out in relation to the emission points specified in schedule 3 tables S3.1 and S3.2 unless otherwise agreed in writing by Natural Resources Wales.

Please install a sample chamber in relation to the permit and provide photographic evidence to NRW by the 3 August 2026.
