4. Details of our assessment

The purpose of this Compliance Assessment Report (CAR) is to record Natural Resources Wales' (hereafter *NRW*) assessment against Bryn Power Limited's (hereafter '*Bryn Power*') **annual** [2025] monitoring and reporting requirements. NRW's assessment of Bryn Power's monitoring returns data is outside the scope of this CAR and any non-compliance arising from an exceedance of a permitted emission limit will be recorded in a separate CAR.
