4. Details of our assessment

On the 26th of May 2026, Environment Officer Callum BRANNAN carried out an OSM Audit at Buckley (The Willows) Sewage Pumping Station (SPS). 4 DCWW staff were in attendance. The purpose of the audit was to ascertain whether the SPS was operating as per the permit. On the day

there were no apparent issues as the SPS.

Conditions on the day were dry, and the storm discharge outfall was located at SJ 27385 65265. The headwall showed no evidence of sewage fungus build up.



A data request will be submitted for the SPS and a data audit will follow.
