4. Details of our assessment

The non-compliance listed above was identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions, UV conditions and Urban Waste Water conditions.

Please note: this CAR is dated 25/11/2025 as these non-compliances relate to annual 2025 data, however for clarity I carried out the compliance assessment on 14 May 2026.

'An error occurred when preparing the file for submission using the current MACRO. We tried to recreate the issue observed, however, we were not successful.
