### 4. Details of our assessment

*The non-compliance listed above was identified during our annual 2025 data audit. This*

*audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions and UV conditions.*

*Please note: this CAR is dated 31/12/2025 as these non-compliances relate to annual 2025 data, however for clarity I carried out the compliance assessment on 14 May 2026.*

*Correspondence received from DCWW 26/06/2026*

*'A number of sites have been deemed to have a shortfall in 2025 due to the addition of "deviating analysis" comments to samples where the bacteriological analysis was commenced outside of the 24-hour stability window.*

*To prevent a recurrence in 2026, we have made the decision to reschedule any samples that meet the same criteria. Please note that this means that some of the samples already submitted for Q1 of 2026 have had deviating analysis comments added, additional samples have been taken to replace these in the compliance assessments for each site.*

*going forward, any samples where the analytical stability window has been exceeded will now be cancelled, and additional samples taken to ensure that the required number of samples are taken, analysed and submitted in order to avoid a sampling shortfall in 2026.'*
