4. Details of our assessment

The non-compliance listed above was identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works

and water treatment works with Operator Self-Monitoring (OSM) conditions and Urban Waste Water conditions.

Please note: this CAR is dated 31/12/2025 as these non-compliances relate to annual 2025 data, however for clarity I carried out the compliance assessment on 14 May 2026

'Steps have been put into the Annual Build process to ensure that all frequencies are distributed evenly throughout the year. The rules are as follows:

For FQ of 4 - 1 per quarter

For FQ of 6 -1 per 2 months

For FQ of 12 - 1 per month, with the exception of some sites where we may schedule the December sample in either October or November based on previous issues experienced on site in December.

For FQ of 24 - 2 per month, again, some sites may have 1 sample in December and 3 in November. this has been accepted by NRW.

Any errors are flagged with the scheduling team and new dates will be requested to ensure the rules are applied.'
