### 4. Details of our assessment

A Schedule 5 Notification was submitted to Natural Resources Wales (NRW) on 15/05/2026 to report an elevated total suspended solids (TSS) result at the Clogau St

Davids discharge point. The sample analysed via a Palin test kit returned a result of 101 mg/l, as compared to the permit limit of 20 mg/l.

It is understood that mitigation measures were initiated by staff on site because of this Palin test result.

On the same day, NRW's Regulatory Monitoring Team independently collected a compliance sample from the site. NRW's sample was taken at 13:25 on 14/05/2026 and, following laboratory analysis, returned a TSS result of 17 mg/l, which is compliant with the permit limit of 20 mg/l.

As NRW's independent monitoring result was within the permitted limit, NRW confirms that no further regulatory action will be taken in relation to this notification. We also acknowledge that the notification being sent to us meant Clogau-St. David's Gold Mine complied with condition 4.3.2 in the permit.

Natural Resources Wales thanks the operator for promptly reporting the Palin test result and taking the necessary action.
