4. Details of our assessment

This Compliance Assessment Report is being produced following a review of the Technically Competent Management provision and submission of waste returns for Llwynfynwent.

This review was conducted by Luke Taylor (Senior Officer - Waste Regulation) of Natural Resources Wales.

W1A General Management - Paragraph 2 (6)(b) of Part 3 Schedule 9 Environmental Permitting Regulations 2016

The above legislation inserted the requirement to your permit that you must comply with the CIWM/WAMITAB Operator Competence Scheme. The current continuing competency qualification held by Mr Oliver is valid for the activities being undertaken at site. This award will expire on 30th April 2027.

W4B Reporting - Permit Condition 6.1.1 - Category 3 Breach

You have been scored for the above breach as your permit requires that a summary of the waste types and quantities accepted and the waste types and quantities removed from the site be submitted for each financial year, and shall be submitted to the agency within one month following the end of that year. No waste returns have been submitted to NRW for the year 2025 as required by the end of January 2026.

Waste returns must be submitted, even if the site did not accept or remove any waste during this reporting period. Under permit conditions 5.3.1 and 5.3.3, records should have been maintained of all wastes accepted and dispatched from the site, so this should be an achievable time frame.

ACTION - Submit annual waste returns to NRW. Deadline 31/08/2026.
