4. Details of our assessment

DCWW self reported a spill to the environment from Ty Gwyn WwTW on 2nd June 2026. DCWW submitted a storyboard on 11 June 2026, detailing their investigation findings and actions that were undertaken to rectify the issue.

Telemetry data shows that the spill to environment occurred between 20:10 - 21:00, with FPF at zero between approximately 20:10 and 20:40 where it then began to recover. The duration of the spill was approximately 50 minutes.

DWWW reported that the spill was due to a PLC COMMs failure which resulted in a premature spill to the environment. The standby ICA technician was called to site and resolved the issue, allowing flows to return to normal and the site to return to operation.

A sample of the spill discharge was collected, however, due to limited daylight no sample from the receiving environment was collected. A downstream sample was collected the following day. Due to access issues no upstream sample was collected. The discharge sample results for ammonia and turbidity were consistent with final effluent quality. The downstream sample has been disregarded due to the time laps between the spill and collecting the sample.

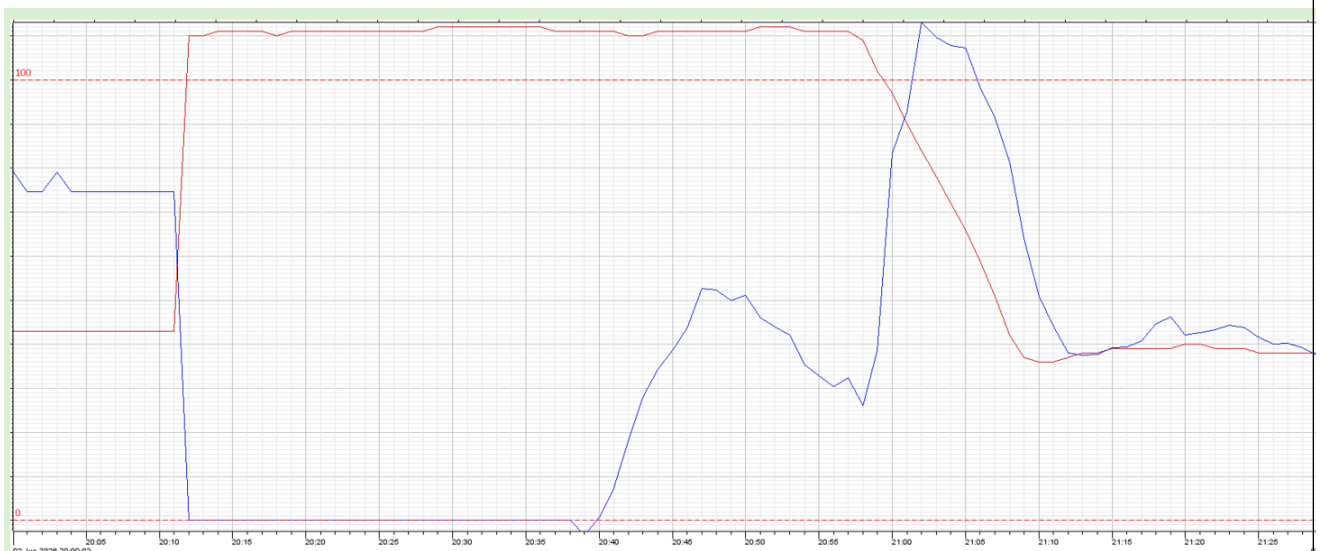


Figure 1. Telemetry data showing the spill to environment (red) trend against the FPF (blue) trend.
