Magda Leonowicz the waste regulation officer and Suzanna Cohen the waste enforcement officer went to the Court Road, CA site on Court Road , Barry, CF63 1ET, on 15/06/2026/. Permit number EPR\ JB3535RS.

Upon arrival, the site appeared to be permanently closed. A notice displayed on the main gate stated that the site had been closed since 1 October 2019. The entrance gates were locked, and access to the site was secured.
