4. Details of our assessment

On 07/07/2026, Waste Regulation Officers; Marc Campbell and Senior Waste regulation officer Laoni Tye attended, Alun Griffiths (Contractors) Limited Rover Way Cardiff Docks Cardiff CF10 4TS to conduct a final site inspection and to assess the risk of; EPR-BB3795FV.

The operator holds a: Tier 2 bespoke permit based on SR2010 No12 - Treatment of waste to produce soil, soil substitutes and aggregate. The site is no longer operational.

Site Assessment:

Paragraph 14 of Schedule 5 of ERP 2016 states:

14. (1) The regulator must accept an application for the surrender of an environmental permit in whole or in part under regulation 25(2) if it is satisfied that the necessary measures have been taken—

(a) to avoid a pollution risk resulting from the operation of the regulated facility and, in the case of a permit authorising the carrying on of a flood risk activity (in whole or in part), to avoid any of the risks specified in sub-paragraph (3), and

(b) to return the site of the regulated facility to a satisfactory state, having regard to the state of the site before the facility was put into operation.

The current site has been taken over by Amazon, and a large car park and warehouse now resides within the site boundary.

There was no waste left over from the previous site's operation and the site has been left in a clean and safe state and is covered by a tarmacked car park.

No major breaches or environmental incidents have been recorded at the site whilst in operation, therefore I have assessed the site as Low Risk.
