Parts of permit assessed: Discharge sample analysis

Report sent to: Director of Property Services, Permit Holder, on 09/07/2026.

On 11th June 2026 a routine sample was taken and analysed to ascertain compliance with permit conditions.

Condition 6 states that the maximum volume of suspended solids must not exceed **30mg/l**.

The analysis recorded **36mg/l** of suspended solids which is a breach of permit condition.

Please ensure action is taken to ascertain the cause of the breach and take measures to prevent a recurrence - before 7th August 2026.

If you disagree with the content of this Compliance Assessment Report form, you should submit your concerns, in writing, to the regulating officer who issued it within **15 working days** of its issue. This will be treated as a **Stage 1 review**.

If you are not satisfied with the outcome of the stage 1 review, you may request a **Stage 2 appeal**. This request must be submitted **within 21 working days** of receiving the response from the stage 1 review.
