4. Details of our assessment

Site Inspection Report – BODNANT GARDEN – NT (Permit WQD003925)

On 7 July 2026, NRW Officer Nathan Owen conducted a routine inspection of the Bodnant Garden National Trust wastewater treatment works, operating under Environmental Permit

WQD003925.

Site Conditions

Weather conditions at the time of the inspection were dry and warm, with a light breeze present. The area had experienced no significant rainfall for several weeks prior to the inspection.

Inspection Findings

A visual inspection of the treatment plant confirmed that the works were operational at the time of the visit. The site operator advised that the treatment plant had recently undergone a full service, during which repairs were completed to improve the performance and efficiency of the treatment process.

A visual assessment of the final discharge outfall was also undertaken. No issues were identified, and there was no discharge taking place at the time of the inspection. The outfall area appeared to be in satisfactory condition, with no evidence of pollution or operational concerns observed.

Conclusion

At the time of the inspection, the treatment works appeared to be operating satisfactorily, and no immediate environmental concerns were identified.
