4. Details of our assessment

This was an announced site visit made by Alex Underhill, accompanied by Dave Ellar of Natural Resources Wales (NRW). The purpose of the inspection was to assess compliance against the tier Standard Rules SR2011 No4 Environmental Permit EPR-CB3495FF.

It was noted that there had been periods of hot weather recently.

Previous inspection:

No permit breaches were observed during the last inspection dated 28/11/2025. Please see Compliance Assessment Report CAR_NRW0050048 for further detail.

Permit Breaches:

No permit breaches were observed during this inspection.

General observations:

The site was generally very clean and well organised, with good segregation of waste types and good waste storage practices were observed.

General Management (W1A):

The site is required to be operated in accordance with a written management system that identifies and minimises risks of pollution.

Operating Techniques (W2C):

Several major changes had been made since the previous inspection to both the operating techniques and the site layout in order to improve both dust management and operational efficiency. Site storage has been changed from linear rows to a cove shaped layout to contain dust during processing. Staff training, personnel changes and investment in machinery have been implemented to significantly reduce the dust emissions leaving site. These changes will need to be updated in the DEMP documentation.

The Site (W2D):

All specified waste sections were kept separate and site was well maintained. The site itself in well maintained and clean, with recent improvements done to the drainage and impermeable surfaces. There are plans to resurface the existing concrete surface to aid in removing surface water and drain away to water tanks installed in the corner of the site.

Records (W4A):

Up to date EMS and Site Permit were readily accessible on site. Due to recent improvements to the site's operating procedures and setup, the EMS, FPMP and DEMP do not reflect the current process,

and are therefore non-compliant. However, these changes are seen as improvements and after assessment by the inspecting Officers, pose no increased risk. Documentation needs to be amended to reflect these changes.

ACTION – Ensure that all relevant documentation including the EMS, FPMP and DEMP, are amended to reflect the new ways of working. This is expected to be completed within 3 months. DUE DATE 20/10/2026
