4. Details of our assessment

The non-compliance listed above was identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions, UV conditions and Urban Waste Water conditions.

Please note: this CAR is dated 31/12/2025 as these non-compliances relate to annual 2025 data, however for clarity I carried out the compliance assessment on 14 May 2026.

Correspondence received from DCWW 26/06/2026

'E-mail from NRW 21/05/2025 set out the expectation that although the frequency for this site was increased in error, the change to frequency needed to be reported on the ASR as a record of why it happened.

This was not taken into account when producing the ASR. Going forward, any correspondence from the regulator that relates to any addition to the ASR are now documented and saved with the draft ASR for the year of reporting.

Further improvements have been made with the tracking / production of the "Frequency Change" tab of the ASR to allow accurate details of each event.'
