4. Details of our assessment

On 14 July 2026 a revised and updated Odour Management Plan was submitted to Natural Resources Wales. A review of the Odour Management Plan was undertaken.

Your Environmental Permit states the following:

3.2 Odour

3.2.1 Emissions from the activities shall be free from odour at levels likely to cause pollution outside the site, as perceived by an authorised officer of the Environment Agency, unless the operator has used appropriate measures, including, but not limited to, those specified in any approved odour management plan, to prevent or where that is not practicable to minimise the odour.

3.2.2 The operator shall:

- (a) if notified by the Environment Agency that the activities are giving rise to pollution outside the site due to odour, submit to the Environment Agency for approval within the period specified, an odour management plan;
- (b) implement the approved odour management plan, from the date of approval, unless otherwise agreed in writing by the Environment Agency.

Following a review of the Odour Management Plan and the attached appendices, **Natural Resources Wales can confirm this Odour Management Plan (dated 14 July 2026) has been approved.**

Natural Resources Wales is satisfied that on this date you are compliant with Condition 3.2.2 (a) of your Environmental Permit.

Natural Resources Wales officers may wish to assess compliance with this plan in future inspections.
