4. Details of our assessment

Thank you for submitting your Climate Change Risk Assessment (CCRA) for The Royal Mint Limited. We have completed a light-touch review of the assessment against NRW's CCRA requirements. Please note: the review is considered a light touch review, only to assess if the CCRA is up to date and includes the expected information, it is not a technical review.

CCRA REVIEW

The CCRA is clearly site-specific and considers a range of climate hazards relevant to the activities carried out at the installation. It also makes reference to future climate projections and identifies a number of appropriate mitigation and adaptation measures. However, there are some areas where further information is needed before the assessment can fully meet NRW's requirements.

In particular, the assessment should:

- Clearly distinguish between **short-, medium- and long-term climate change risks** relevant to the installation.
- **Identify and prioritise the elements most vulnerable to climate change**, including assets, infrastructure, operations, supply chains, ecosystems and people. While some of these are discussed within the assessment, a more structured approach to identifying and prioritising climate-sensitive receptors is required.
- Include **Key Performance Indicators (KPIs)**, or other measurable indicators, to demonstrate how the effectiveness of climate adaptation measures will be monitored over time.
- Include a **formal review and update process** to ensure the assessment remains current and is reviewed following new climate data, emerging climate trends, significant climate-related incidents, or near misses.

A robust management system helps ensure environmental risks associated with permitted activities remain effectively controlled as climate conditions change. While the assessment provides a good foundation, the points above need to be addressed to demonstrate a comprehensive approach to climate change adaptation and continual improvement.

ACTION: Provide a revised CCRA to include the recommendations highlighted within the CAR Form and submit to Natural Resources Wales by **25/09/2026**.

Following this, the next step is for you to develop a Climate Change Adaptation Plan (CCAP) based on the findings within your CCRA and integrate into your management system. The detail in your CCAP should reflect the risk that climate change creates for your operation. Following the Regulation 61 Notice issued to the The Royal Mint Limited, this CCAP will need to be completed and submitted to NRW by **01/04/27**.
